## 2022 Wild Westover K9 Fitness & Fun Facility Rules

All dogs must be up to date on vaccines. This includes Rabies, Bordetella and Distemper. Titers are accepted.

Please pick-up after your dog and properly dispose it in trashcans. Please potty your dog before going on the dock or agility field. Female dogs in heat are NOT allowed at the facility.

No raw treats or raw food items allowed on the agility field. The agility field and pool will be closed during unsafe weather.

All dogs are expected to be non-aggressive towards other dogs or humans. If your dog shows signs of aggression, we reserve the right to ask you to leave. If you have a reactive dog, please let us know up front and reserve private sessions only. Group Classes and Open Dock are for non-reactive dogs only.

For the safety of your dog, we do not allow choker, shock, or prong collars on the dock or when training on the agility field. All dogs MUST be leashed at ALL times unless they are on the dock or on the agility field. You must keep your dog under control and use a 4-6 foot lead. No retractable leashes are permitted. During Private Sessions your dog is allowed to be "off leash" in the dock area or agility field only.

You will be responsible for any damage (dock, crates, agility equipment or property) caused by your dog.

Please closely supervise any accompanying minor children at all times. Do not leave dogs or children unattended in vehicles, regardless of the temperature.

No pushing your dog off the dock or forcing your dog on agility equipment. All toys being used in the pool must be floatable and non-edible. All dogs should be clean, brushed and nails trimmed to protect the pool liner and agility equipment.

## **Photo Release and General Release of Liability**

I authorize Wild Westover K9, WestRover Water Sports & photographers to photograph and/or video my dog or me and to use these images in future books, videos, promotional or educational materials, and hereby waive my claim to any compensation for such use.

I, the legal owner of this/these dog(s), or its handler, understand that I am releasing, waiving, discharging and covenanting not to sue Wild Westover K9 Fitness & Fun and WestRover Water Sports (hereafter referred to as Wild Westover), American Kennel Club (hereafter referred to as AKC), North America Diving Dogs (hereafter referred to as NADD) and Jennifer Crisman for losses or damages and any claim of damage of any kind on account of sickness, death, loss or and/or injury to my dog or any other dog or person, as a result of negligence or otherwise, while the dog is on Wild Westover's premise. I am aware that there are inherent risks and hazards involved in activities at Wild Westover, with and around dogs, and I am voluntarily participating in these activities with the knowledge of these potential dangers. I hereby waive any and all claims or actions that I, or my guardians, representatives, or assigns may have against Wild Westover, and agree to release Wild Westover from any and all liability for personal injury to myself, my dog, children in my charge, or harm to property caused directly or indirectly by acts that might occur while on the Wild Westover premises. I further agree to indemnify, defend and hold Wild Westover harmless for damages, loss liability or expenses, including legal costs and attorney's fee which result from any damage caused by myself, children in my charge, or dog(s) that I own or handle.
